What are the specific accomplishments, projects or activities that you have had for the reporting period?

I have written three RVC columns (January, February, and March). I attended the December AMC meeting and participated in the January AMC teleconference. In December, I attended the Finance Committee and Communication Committee meetings.

I have been in touch with South Texas Mensa to review their plans for the upcoming March 2016 AMC meeting.
