What are the specific accomplishments, projects or activities that you have had for the reporting period?

I have written three RVC columns (April, May and June). I attended the March AMC meeting and participated in the May AMC teleconference. I also participated in the April Finance Committee teleconference with our auditors. I have chair a subcommittee of the Leadership Development Committee that is developing a new online training tool for volunteers. I participated in review of bids for future AGs as a part of the Site Selection Committee. I helped judge entries for the Achieving Communications Excellence program as a member of the Communications Committee.

I traveled to visit four local groups during this quarter – Baton Rouge Mensa, Permian Basin Mensa, Lubbock Mensa, and Central Oklahoma Mensa. All of these meetings were well attended by local group members, and I was able to get new volunteers to step up to serve as LocSec and Membership Officer in Baton Rouge Mensa.
